Established in 1921, the New Jersey Real Estate Commission (REC), a division of the New Jersey Department of Banking and Insurance, was created to administer and enforce New Jersey's real estate licensing law, N.J.S.A. 45:15-1 et seq.

The REC issues licenses to real estate brokers and salespersons, real estate schools, and course instructors, as well as establishes standards of practice for the real estate brokerage profession. It also regulates and registers out-of-state sales through New Jersey brokers.

Attorney General Gurbir S. Grewal has updated the **Letter to Property Owners** concerning housing discrimination. It is required by N.J.A.C. 11:5-6.4(j) that real estate licensees supply a property owner with this letter, when accepting a listing of property for sale or rental.

1.) Verify your 6-year RA Anniversary Date (mm/dd/yyyy)  NOTE: If exact date not known, contact NJREC at (609) 292-7272	Do nothing. CE is not currently required for RA's.	As a full-time licensee, complete all CE, required for license renewal, by 04/30/2019.
2.) Complete required CE to change license type. See CE RA chart for CE amounts to be completed.  NOTE: Use CE types Core or Ethics only		
3.) Work with Broker of Record (BOR) only to change (on-line) RA to active Salesperson (SP) or Broker (BR) license type.  NOTE: BOR cannot change license type until CE Provider/Instructor loads CE in PSI/NJREC CE database then wait another 24 hours to be loaded into NJREC Licensing database.		
4.) Full-time licensee can change license type back to RA after 48 hours, if desired.
